

FAFSA Application Deadlines

The Free Application for Federal Student Aid (FAFSA) is the federal application for financial aid. This application is also used to apply for aid from other sources, such as state and school.

FAFSA application processes:

1. Complete the FAFSA application on-line at www.fafsa.gov
2. List East Los Angeles College's institution code: **001222**
3. After the FAFSA is submitted on-line, it may take anywhere between 3 to 15 days for the Department of Education to forward your information to our campus.
4. Therefore, it is to your advantage to apply as early as possible to meet the application deadline, we must have all of your documents by the last day of your enrollment period; we recommend that you do not go beyond the date listed below to submit your application.

California Dream Act Application Deadlines

The California Dream Act Application for State funds is the state application for financial aid for Dreamer or DACA students. This application is used to apply for state aid such as California College Promise Grant (CCPG) (Fee Waiver), **the following Grants have a deadline of March 2, 2018**, **Fulltime Student Success Grant (FTSSG)*, Community College Completion Grant (CCCG)*** or other resources from the state.

California Dream Act application processes:

1. Complete the California Dream Act application on-line at <http://dream.csac.ca.gov>
2. East Los Angeles College's institution code: **02226000**
3. After the Dream Act Application is submitted on-line, it may take anywhere between 3 to 15 days for the California Student Aid Commission to forward your information to our campus.
4. Therefore, it is to your advantage to apply as early as possible to meet the application deadline, we must have all of your documents by the last day of your enrollment period; we recommend that you do not go beyond the date listed below to submit your application.

*To be eligible for FTSSG and CCCG, you MUST be a Cal Grant recipient in order to be considered for these grants.
