III. APPROVAL OF MINUTES

Chief Delegate Jennifer Estrada **motioned** to approve the minutes of the discussions held in the ASU meeting which took place March 2, 2012, and was **seconded** by Commissioner of Psychology Mariana Garcia. Motion passed unanimously.

IV. PUBLIC FORUM

- 1. CAFÉ representative speaks on behalf of this organization asking for a letter of support from ASU. Time runs out. Chief delegate Estrada Motions to extend time and is seconded by Treasurer Wendy Arredondo. Item is furthered developed, and time runs out. Commissioner of Journalism Isaac Tovar motions to extend time and is seconded by Commissioner of Journalism Administration of Justice Tony Alonzo. Discussion ends with committee agreeing to supply requested letter.
- 2. Jason a representative of Respiratory Therapy Club asks for help from ASU as he wants to collect \$25/student for his association. Motion passed unanimously in the amount of \$2,300.

Chief Delegate Estrada motions to add chartered clubs to the agenda as Action item A1 and is seconded by the Commissioner of Administration of Justice Alonzo.

- B. Fund Accounting Club in the amount of \$3,800 is motioned by Commissioner of Journalism Tovar and is seconded by Chief delegate Estrada. Treasurer Arredondo recommends amending original amount of \$3,300 to \$2,500.

Chief Delegate Estrada motions to entertain Discussion Item number one and is seconded by Commissioner of Journalism Tovar.

- 1. Protocol for Club Fund Disbursement (Round Table Discussion)
 - Set deadline to submit Banquet paperwork since they are the major reason for exhaust in accounts. Time expires and Historian Cruz extends time by 10 minutes and is seconded by

- Commissioner of Health and Safety Andrew Gonzalez. Discussion ends with committee agreeing to approve no more than half what is asked.
- Chief Delegate Estrada motions to table item till further notice and is seconded by Commissioner of Journalism Tovar.

Motion to Entertain Action Item B Found Accounting Club is motioned by Treasurer Arredondo and seconded by Commissioner of Psychology Mariana Garcia

- B. The discussion to fund the accounting club in the amount of \$3,800 is resumed. Historian Cruz motions to reduce requested \$3,800 by half giving a total of \$1,900 and is seconded by Commissioner of Journalism Tovar. Motion is put into a vote and passes unanimously.
- C. Fund Art Department in the amount of \$1501.34 was motioned by the Commissioner of Journalism Tovar and was seconded by Chief Delegate Estrada. Commissioner of Journalism amends to reduce original amount by half giving a total of \$750.67 and was seconded by Treasurer Arredondo . Motion passes vote and Art Department is recommended to prepare documents to get chartered.

Motion to go out of order and discuss action item E Fund ELAC Puente Club is motioned by Secretary Iris Gaytan and was seconded by Historian Cruz

- E. Discussion takes place and Chief Delegate Estrada motions to reduce requested amount of \$2,250 to \$1,125 and was seconded by Treasurer Arredondo. Motion is put to a vote and passes unanimously, however club is asked to bring a list of their attending members.
- F. Fund Engineering Club/ ASME Rolling Huskies in the amount of \$5,200 is motioned by Chief Delegate Estrada and is seconded by Treasurer Arredondo. Motion discussion continues and committee proposes to fund \$2,600, it is put to a vote and motion passes unanimously.

Motion is put to a vote and passes.
