V. Financial Report

A. Vice President of Finance: Vice President of Finance reports that the budget is not updated. He wants everyone who makes proposals to turn in invoices or receipts within the next two weeks so he can update the budget. He included the stipends in the budget in order to determine if the commissioners or senators will get a stipend.

VI. Action item

A. Fund: Blue Painters Tape for ICC & Board: Executive Vice President moves to fund in the amount of \$305.00 Chief Justice seconds. Executive Vice President states that blue tape will be given to clubs in order to post flyers around campus and the remaining rolls will be given to board members in order to post their flyers for events as well. Motion passes with 9:1 vote.

Executive Vice President presents the item and states portfolios will be used to include all the information clubs will need when they are being chartered. Motion passes with a unanimous vote.
