#### I. Commissioners/Senators-

-Commissioner of Vocational Sciences: "I went to the most recent shared governments meeting in October and overall the meeting went well and it was fairly short. Some of the topics that were discussed was about the gender-neutral restrooms, free speech zones, and parking. A quick recap; an issue with the gender neutral restrooms were that they came up suddenly over the summer and the employees of the school weren't so much informed about it nor were they given the opportunity to discuss it. Free speech: currently there's a lawsuit going on about free speech zones in Los Angeles community colleges. If the court rules in favor of the plaintiff then our free speech zones end up being redundant because then the whole campus will be considered a "free speech zone." Parking: faculty and staff are having trouble with students parking in their spaces and there's a lack of cadets to write off tickets. There was major debate on this issue because some reps believed cadets should be issuing more tickets to keep this from continuing to happen but others believe that could conflict the relationship between cadets, students and the school. So I'm working on a plan so that the next sessions of students will know where not to park"

-Commissioner of Social and Behavioral Studies: I'm currently working with the event planning committee for the ELAC Boom days and need to meet with VP Hernandez to discuss the upcoming events that will be taking place on campus and to meet with Chief Justice Hernandez to go through Roberts Laws since I did not attend the first meeting. I am also working on collecting date from this week's conference to present at the next meeting.

-Senator of Political Activism: Food Insecurity Symposium: We have received 142 responses on the survey in regards to food insecurity on campus. ASU will be sponsoring the symposium that will open the discussion in regards to what approach we can take to address the issue. I have yet to meet with Sonia to agree on a date so that it may be held in the multi-purpose room. Transfer Meeting: Columbia University visit Monday, 10/9 12-1:30pm in F5 209. Fall 2017 University Transfer Fair Tuesday, 10/17 10am-1pm E3 Quad. We will need assistance to promote the Fair and our upcoming Transfer Student Success Conference on Saturday October 28th. -Senator of Activities and Planning: I would just like to update you on what our South Gate team is working on. The South Gate team is working on the Christmas pride. Additionally, we have a new office in South Gate. We will be working on getting it operational ASAP. All needs and concerns for the student body have been addressed. Supplies (green books and scan-trons) are being in processed. As for the book rental program we will be taking a survey in South Gate to see if the need is feasible for the need in south gate campus. We will be putting a student suggestion box in at South Gate. This will serve as the ASU information center for further concerns.
