Program Description

This program is designed to prepare students to take the examination to become a State Licensed Real Estate Broker. A licensed real estate broker sells houses and other real estate properties independently or under the guidance of another broker.

Career and Transfer Opportunities

Requirements to Apply for a Real Estate Broker License

Age: You must be 18 years of age or older to be issued a license.

Residence: If you are not a California resident, see Out-of-State Applicants.

Honesty: Applicants must be honest and truthful. Conviction of a crime may result in the denial of a license.

Experience: Either, a minimum of two years full-time licensed salesperson experience within the last five years, or two years of unlicensed equivalent experience, or a four-year degree with a major/minor in real estate is required.
